In accordance with A Culture of Honesty, the university's academic honesty policy and procedures, we are providing the University Council with the attached report for the 2021-2022 academic year. Semester reports are on the <u>website</u>. We are also pleased to report on the following highlights from our office:

- Attended International Center for Academic Integrity (ICAI) international (virtual) conference in March 2022;
- Continued enrollment in eLC academic integrity module, with 839 students enrolled in the 2021-2022 academic year and 574 students earning the module badge;
- Launched remediation program in Summer 2022 for undergraduate students who acknowledged a violation.

In addition to administering the university's academic honesty policy and speaking to numerous groups of students, faculty and teaching assistants, we continue to make every effort to resolve faculty concerns about possible cases of academic dishonesty quickly and fairly. We appreciate the assistance provided by our faculty and professional staff who assist in facilitating academic honesty discussions, the service of faculty and students who volunteer to serve as panel members, and to those who support and promote academic integrity at UGA by reporting concerns, requesting speakers, and seeking guidance about issues of possible academic dishonesty.
