**RE: Annual Report on Academic Honesty Cases
2016-2017**

In accordance with A Culture of Honesty, the university's academic honesty policy and procedures, I am providing the University Council with the attached report for the 2016-2017 academic year. This past year marks the third yearly decrease in the number of students reported, with a 15% decrease in reports from the 2015-2016 to the 2016-2017 academic year. I'm also pleased to report on the following highlights from our office:

- As of Fall Semester 2017, the use of Advocate by Symplicity software (used by other units on campus) for case management and reporting, along with an updated website and online reporting form for instructors and other members of the university community;
- An orientation session on August 15, 2017 for 21 new faculty and 13 new student panelists as well as 7 new facilitators, with facilitation skills training lead by a team from the Fanning Institute of Leadership Development; and
- Upon approval of University Council, the inclusion of the College of Veterinary Medicine in A Culture of Honesty.

In addition to administering the university's academic honesty policy and speaking to numerous groups of students, faculty and teaching assistants, we continue to make every effort to resolve faculty concerns about possible cases of academic dishonesty quickly and fairly.

I am grateful for the years of service and leadership of my predecessor and for the assistance provided by our faculty and professional staff who assist in facilitating academic honesty discussions, the service of faculty and students who volunteer to serve as panel members, and to those who support and promote academic integrity at UGA by reporting concerns, requesting speakers, and seeking guidance about issues of possible academic dishonesty.

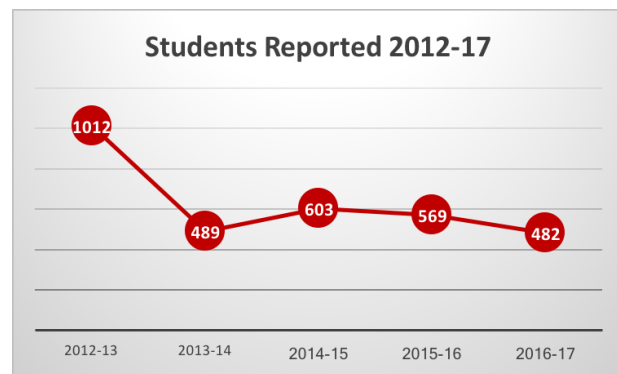

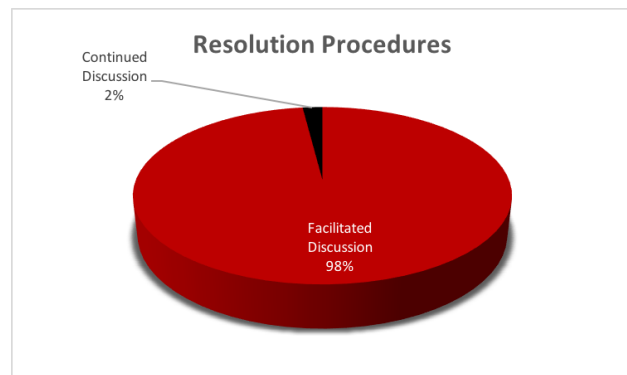
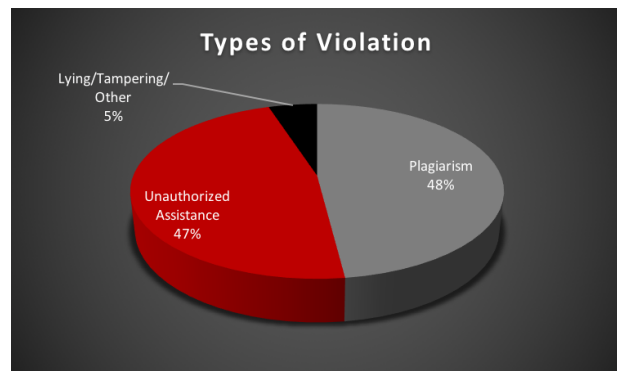
Overview
