## PROPOSAL FOR MINOR PROGRAM OF STUDY

#### 1. School/College: School of Social Work

#### 2. Department/Division: <u>School of Social Work</u>

#### 3. Proposed Program: Minor in Social Work

### 4. Proposed Starting Date for Program: Fall 2020

#### 5. Program Description:

A minor in Social Work will provide undergraduate students an opportunity to acquire a knowledge base for persons interested in the values and profession of Social Work, with special emphasis in social justice, service, dignity and worth of the individual, importance of human relationships, integrity, and competence.

#### Requirements

- Minimum of 2.5 overall GPA is required to declare minor.
- Must earn at least a "C" grade in each minor course.
- A minor must contain at least 9 hours of upper-division course work.
- Courses taken to satisfy Core Areas I through V cannot be counted as course work in the minor.
- Courses taken in Core Area VI may be counted as course work in theminor.
- Submit a Social Work Minor Application
