PROPOSAL FOR MINOR PROGRAM OF STUDY

7. Program Description:

The purpose of the minor is to increase students' exposure to the culture and language of Quechua speaking populations in South America and beyond. The minor also provides additional opportunities for students to develop increased linguistic proficiency in speaking, reading, and writing in Quechua.

8. Program of Study:

- A minor must contain at least 9 hours of upper division course work.
- Courses taken to satisfy Core Areas I through V may not be counted as course work in the minor.
- Courses taken in Core Area VI may be counted as course work in the minor.
- All courses used to satisfy the minor requirement must be passed with a grade of "C" (2.0) or better.
- At least three of these courses must be taken in residence.

Students seeking a minor in Quechua must complete 15 hours as follows:

9. Justification

As part of its successful application for the only National Resource Center Title VI Grant at UGA, the Latin American and Caribbean Studies Institute initiated its Quechua language program in 2014. Along with Portuguese (which currently offers a minor), Quechua is one of two less-commonly taught languages that qualify for Foreign Language and Area Studies Fellowships through the NRC Grant, both for academic year and summer study.

A few peer and aspirational universities currently offer varying levels of Quechua language instruction (UCLA, U. Penn, Michigan, NYU, Illinois, Pittsburgh, Utah), though to our knowledge, UGA would be the first institution to offer a Quechua minor.

Multiple students have expressed interest in the minor as a motivation for enrolling and continuing with the language, as it would offer a means to officially document their linguistic and cultural competency. We therefore believe the minor will additionally help draw attention to the language, highlight resources such as the FLAS opportunity for institutional and tuition support, and increase recruitment.

As an institute whose reach spans across campus and academic disciplines, LACS comprises core and affiliate faculty with cultural, political, and scientific expertise in Andean and indigenous studies as well as Latin American and Caribbean research. The minor will offer students who pursue training in this area a credential that will especially complement their scholarship and enhance their marketability to employers who work with emerging sectors across the region.
