Re: COVID-19 and Fall 2021 at The University of Georgia

As elected representatives of the UGA faculty serving on the University Council's Faculty Affairs Committee, we are charged with addressing faculty concerns. There is an outpouring of apprehension related to the rising number of COVID-19 cases in our area and the lack of decisive public health safety measures in the planning and opening of the 2021 Fall Semester at UGA.

Three recent developments are of special concern:

- The fully vaccinated rate in Georgia, the eighth lowest in the country, is below 40%. Clarke
  County's rate of vaccination is even lower while the rate of infection, due to the delta variant,
  is growing exponentially. Clarke County is among the top 20% most vulnerable counties in
  the Pandemic Vulnerability Index as reported by the National Institute of Environmental
  Health Sciences (https://covid19pvi.niehs.nih.gov/).
- Masking in public indoor areas is recommended by the CDC, whether vaccinated or not vaccinated, in areas of substantial or high transmission of COVID-19

Almost all counties in Georgia and its neighboring states have a high rate of transmission as defined by the CDC. Further, Athens-Clarke County (ACC) passed a mask mandate, the ACC School Board also passed a mask mandate for teachers, staff, and students regardless of their vaccination status, and several SEC schools have implemented mask mandates (e.g., Alabama, Auburn, Ole Miss).
- The area hospital capacity continues to diminish, with times when ICU and Emergency services have to be diverted due to reaching admission limits/bed availability (see https://dph.georgia.gov/covid-19-daily-status-report and https://georgiarcc.org/).

Based on these concerns, and in the interest of the safety of our campus, we urge you to work with the Governor and the Board of Regents to implement the following common-sense safety measures:

- Mandate COVID-19 vaccinations for all faculty, staff, and students who are medically able to
  do so and who do not have a religious exemption. This should occur immediately or
  immediately after the vaccines are fully approved by the FDA. <u>U.S. Supreme Court Justice</u>
  <u>Amy Coney Barrett recently</u> refused to block a <u>unanimous lower court decision</u>—in the
  Seventh Circuit—that permitted a state university to mandate COVID-19 vaccination. Given
  the current pandemic, mandated vaccination aligns with the <u>BOR policy that permits</u>
  <u>immunizations in exceptional circumstances</u>
- Mandate that everyone wear a mask when indoors per CDC guidelines. Exceptions should be made for those with documented medical conditions preventing a mask/face covering.
- Mandate randomized large-scale testing of faculty, staff, and students to enable the identification and isolation of those with COVID-19.

We respectfully request that you address these concerns as quickly as possible so that changes can be implemented as we begin the 2021 Fall Semester. We are willing and happy to help the President in any way we can to lobby the Governor and Board of Regents to change current policies to protect the health and safety of the University of Georgia community and the safety of the larger Athens community.
