Proposal for a Minor Program of Study

School/College: Franklin College of Arts and Sciences

Program Description:

The proposed Minor in the History of Science, Medicine, and Engineering aims to give undergraduates a solid foundation in the historical foundations of the so-called "STEM" disciplines that have attracted a growing number of majors in recent years. The impetus for this proposal originated with faculty members in these disciplines who contacted the History Department. Several expressed concern that students majoring in cutting-edge technical fields have insufficient opportunity to develop the kinds of skills associated with historical training: the ability to write effectively and clearly, the capacity to weigh contradictory evidence and draw logical conclusions, and other "critical thinking" skills.

Courses in the proposed minor will enable students to develop these essential competencies while simultaneously giving them a grounding in the history of their chosen fields: engineering, computer science, biology, public health, psychology, and other allied disciplines. For students in these fields, a Minor in the History of Science, Medicine, and Engineering may also give them an edge in the job market, enabling them to argue that their undergraduate training has given them not only specialized technical skills but also the general, transferable skills necessary for success in the contemporary labor market. Though designed with these students in mind, this minor will also accommodate the interests of any student interested in historical studies that have a more applied, technical focus.

Student learning outcomes for this program include: 1) Develop an awareness of the historical roots of technical, medical, and scientific fields; 2) Acquire an understanding of how these fields became professionalized and integrated into the larger economy; 3) Read and analyze historical documents in order to practice developing cogent, persuasive arguments in writing; and 4) Develop communication skills consistent with students' academic and professional goals.

Program of Study and Requirements

Students pursuing a Minor in the History of Science, Engineering, and Medicine must take fifteen hours of coursework from the following list. There is no geographical or topical focus; any five courses drawn from the following list will suffice, subject to the following rules.

- No more than one of the five courses can be taken outside of the HIST prefix
- Courses taken to satisfy Core Areas I through V may not be counted toward the minor.
- Courses taken to satisfy Core Area VI may count for the minor.
- All courses used to satisfy the minor must be passed with a grade of "C" (2.0) or better.
- Upon approval, transfer students may count one non-UGA course toward the minor.

Justification:

In recent years, students at the University of Georgia have gravitated in growing numbers to preprofessional majors, particularly those associated with STEM (Science, Technology, Engineering, and Mathematics) fields. Nonetheless, informal polling undertaken by faculty in the School of Engineering indicates that there remains significant demand for traditional disciplines like History – but only if they complement and reinforce studies undertaken in the primary major. The conventional History Minor does not permit students to do this: it is defined by geography, not subject area. By contrast, this new minor field would be tailor-made to accommodate the needs and wishes of students pursuing studies in STEM fields, offering a range of upper-level courses designed to meet this demand.
