#### RE: Annual Report on Academic Honesty Cases 2023-2024

Dear Dr. Rice:

In accordance with A Culture of Honesty, the university's academic honesty policy and procedures, we are providing the University Council with the attached report for the 2023-2024 academic year. Semester reports are on our new <u>website</u>. We are also pleased to report on the following highlights from our office:

- 1,853 students (1,213 undergrad, 640 grad) completed the Academic Integrity Modules in eLC and earned the Academic Honesty Badge;
- 58 students completed the Remediation Program; 98% of Remediation Program graduates would recommend it to other students;
- Hosted free coffee stations for students on the first day of finals in Fall and Spring semesters; and
- Presented at the International Center for Academic Integrity (ICAI) annual conference in March 2024; two students attended and presented posters thanks to a grant from the Parents Leadership Council.

In addition to administering the university's academic honesty policy and speaking to numerous groups of students, faculty and teaching assistants, we continue to make every effort to resolve faculty concerns about possible cases of academic dishonesty quickly and fairly. We appreciate the assistance provided by our faculty and professional staff who assist in facilitating academic honesty discussions, the service of faculty and students who volunteer to serve as panel members and as remediation representatives, and to those who support and promote academic integrity at UGA by reporting concerns, requesting speakers, and seeking guidance about issues of possible academic misconduct.
