The Full University Curriculum Committee met on April 18, 2025, at 3:30 p.m. in 327 Brooks Hall, and August 15, 2025, at 3:30 p.m. in 207 Holmes-Hunter Academic Building. Since the last Report to the University Council, the committee approved 40 new courses and 284 course changes.

The committee unanimously approved the following proposals, which were forwarded to the Executive Committee of the University Council for consideration:

- Proposal for a Minor in Cancer Therapeutics
- Proposal for a Minor in Children's and Young Adult Literature
- Proposal to offer the existing major in Social Studies Education (M.Ed.) online

- Proposal to terminate the major in Reading Education (M.Ed.) on the Athens campus only
- Proposal to terminate the major in Music Education (Ed.D.)
- Proposal for the following institute name change:
 - o From: Institute on Human Development and Disability
 - To: David Ralston Institute for Behavioral Health and Developmental Disabilities
- Proposal to offer the existing major in English Education (M.A.T.) online
- Proposal to deactivate the major in Water and Soil Resources (B.S.E.S.)

The committee unanimously approved a proposal for a new course prefix, MUSE, Museum Studies.

The committee unanimously approved a proposal for an Area of Emphasis in Therapeutics Discovery under the major in Biochemistry and Molecular Biology (M.S., Non-Thesis).

The committee unanimously approved a proposal to terminate the following Areas of Emphasis under the major in Middle Grades Education (M.Ed.): Area of Emphasis in Mathematics and Language Arts; Area of Emphasis in Mathematics and Science; Area of Emphasis in Mathematics and Science and Language Arts; Area of Emphasis in Social Studies and Language Arts; and the Area of Emphasis in Social Studies and Science.

The committee unanimously approved a proposal for changes under the major in Environmental Resource Science (B.S.E.S.), including the creation of an Area of Emphasis in Water and Soil Resources and the termination of the Area of Emphasis in Environmental Chemistry and the Area of Emphasis in Resource Management.

Dr. Susan Sanchez was re-elected as University Curriculum Committee Chair for the 2025-2026 Academic Year.

The administrative home of the Graduate Certificate in Financial Literacy was moved from the Department of Mathematics, Science, and Social Studies Education in the Mary Frances Early College of Education to the Department of Financial Planning, Housing, and Consumer Economics in the College of Family and Consumer Sciences.

The Institutional Competencies Subcommittee met 25 times since February 2025. The subcommittee considered 1,298 courses, of which 1,050 were approved to satisfy at least one of the six different competencies. The subcommittee provided guidance for the submission and resubmission of courses and activities to satisfy Institutional Competencies.
