At the November meeting, several representatives from the Student Government Association presented the concept for a University-wide course, ARCH 1101, Academics, Responsibility, Community, History. The committee members asked questions and provided feedback.

Ms. Kathryn Bowers addressed the committee concerning the lack of compliance with the syllabus policy requiring that an online syllabus be available for student access. Online syllabus information is available for many courses accessible from the Bulletin web site, but there are many courses that do not have an online syllabus available.

The committee discussed the issue of 3000- and 4000-level courses that do not have prerequisites. The committee agreed to send a letter to all departments with 3000- and 4000-level courses that don't require prerequisites asking them to consider adding prerequisites to courses if it is apparent that students are not prepared.

A request was made for the committee members to ask for volunteers in each of the schools and colleges for administration of a general education assessment tool, C-Base, during one class period in January.

The Subcommittee on Plus/Minus Grading was charged with providing guidance for faculty concerning the plus/minus grading system. The subcommittee members discussed a proposal to distribute a document to faculty that includes several sample grading scales that could be used for plus/minus grading. These scales are not required or recommended; they are provided for information only. The UCC agreed to distribute the document to faculty and post it on the web with the Plus/Minus Grading System FAQ.

At the January meeting, the committee approved a request to add CMLT 2600, Multicultural Black Diaspora Literature, to Area C of the Core Curriculum. This request will be forwarded to the Board of Regents' Council on General Education for consideration.

The committee approved, with a minor change in wording, a proposed revision of Academic Affairs Policy Statement No.11, Procedures for Establishing or Changing Implementation Plans for the Cultural Diversity Requirement. The revision includes a set of criteria that will be used when considering courses.
