Dear Dr. Quinlan,

The Student Government Association and Teaching Academy submit for adoption by the university council a Compact for Responsible Scholarship. This initiative was conceived in the SGA, and brought to the Teaching Academy Executive Committee for discussion by Katy Bowers in early 2007. A joint SGA/TA Workshop was organized on this topic in spring 2007. Multiple concurrent small group discussions of faculty and students were very productive, and generated many ideas for mutual expectations of faculty and students. Subsequent meetings with Teaching Academy members allowed us to identify the most important ideas, and to begin to fashion the document. Numerous revisions followed in Fall 2007 through summer 2008, and led to the present version which has been adopted by the Executive Committees of both SGA and the Teaching Academy. We seek your endorsement of this document, and hope to send it on the University Council for adoption later this spring. We thank you in advance for your attention to this matter, and for any assistance that you may be able to provide.
