### PROPOSAL FOR MINOR PROGRAM OF STUDY

School/College: College of Education

**Department/Division:** Department of Kinesiology

**Proposed Program:** Sport Management

**Proposed Starting Date for Program:** Fall semester 2015

**Rationale:** Many students in the Terry College of Business and the Grady College of Journalism and Mass Communication are interested in careers involving sport business or journalism. Some students pursue a dual degree, but others do not want to prolong their program to take the required number of hours of sport management courses in the Department of Kinesiology. A minor requiring a fewer number of sport management courses will meet the needs of many of these students for a credential in sport management.

**Program Description:** The primary objective of the sport management undergraduate program is to provide students with the interdisciplinary knowledge, professional application, critical thinking, problem-solving, and leadership skills necessary to effectively manage sport and exercise programs. Students are provided with learning opportunities to acquire the ability to work with and through diverse groups of people to achieve stated organizational goals. Proficient application of business principles to the sport industry distinguishes this program. Students are also prepared to possess the competitive knowledge and skills to effectively communicate their ideas through both written and oral forms of presentations.
