Art Education (Ed.D.)

The primary purpose of the program is to prepare art teachers at the elementary, middle and high school levels in order to promote the role of the visual arts in learning; to nurture aesthetic sensitivity, to foster critical thinking abilities, and to develop visual literacy. Students may also work toward careers with other agencies and institutions such as community centers and art museums. *See section II for responses to criteria*.

There were no studies conducted to aid in our decision to deactivate this program. We decided to deactivate this program due to low interest of incoming students and low number of recent graduates.

2. State the reasons for deactivating or terminating the program.

We are deactivating this degree due to low number of graduates. We also believe that our other offerings in Art Education cover the aims and constituency of these programs sufficiently.

There are currently no students enrolled in the Ed.D. degree

4. What will be done to minimize the impact or termination of the program upon the personal and professional lives of the faculty and staff involved, specifically a.) how will faculty and staff be notified of the termination and b.) how will faculty and staff be re-deployed?

All faculty and staff associated with the program have been informed and consulted in the termination of the Ed.D. degree. No staff or faculty will need to be reassigned.

5. What will be done to insure that deactivation or termination of the program does not weaken other programs (graduate, undergraduate, or professional) for which the department may be responsible?

We will maintain our M.A.Ed. and Ph.D. programs in Art Education and feel that they give ample options for our students. We don't feel that the deactivation of the Ed.D. program weakens our remaining programs in fact we feel the deactivation of this program adds clarity to our offerings.

6. What plans, if any, are there for subsequent reactivation or reinstatement, respectively, of the deactivated or terminated program?

In the next two years, we will either develop a strategy to re-launch the program or terminate it.
