The Educational Affairs Committee met on October 18, 2021, at 3:30 p.m. online via Zoom.

The minutes of the September 27, 2021, meeting were unanimously approved as distributed.

Chair Annette Poulsen reported that since the last EAC meeting, the Petitions Subcommittee reviewed 20 student appeals. Of those appeals, 16 were approved and 4 were denied.

The committee briefly discussed revisions to proposal 4.06-5, Air Force ROTC Commitment and Summer Break. During discussion, William Vencill, Associate Vice President for Instruction, offered

to meet with the UGA Army and UGA Air Force ROTC programs to obtain relevant data from each program regarding the proposal. Following discussion, a motion to table the proposal was made by Sudhagar Mani and seconded by David Mustard. The committee then unanimously approved tabling the proposal.

Jean Martin-Williams provided the committee with an update on research she has completed regarding the proposed new policy 4.06-6, University-sponsored activities. Dr. Poulsen encouraged committee members to contact Dr. Martin-Williams if they are interested in serving on a subcommittee regarding this proposal.

Phillip Griffeth and Courtney Cullen from the Office of Academic Honesty and Student Appeals offered several information items to the committee, including the annual report on Academic Honesty, results from the McCabe Survey, and revisions to the Academic Honesty Policy. The annual report on Academic Honesty will appear on the agenda of the December 1 University Council meeting. Following the presentation of the revisions to the Academic Honesty Policy, a motion was made by Sudhagar Mani for the committee to vote on the revisions and send the revisions to the University Curriculum Committee for consideration. The motion was seconded by Bartosz Wojdyski. The committee then unanimously approved the revisions as well as sending the revisions to the University Curriculum Committee.

The meeting adjourned at 4:23 p.m.
