Faculty Affairs Committee meeting minutes (created by Daniel Markewitz)

This meeting of the FAC was held in part to address some questions raised about edits to the *Guidelines for the Appointment, Promotion, and Tenure of Academic Rank Faculty* raised at the October 16 meeting of the University Council.

Some concerns were related to use of an old draft, but Janette Hill had some questions she wanted addressed.

Several committee members not at the meeting wanted to vote, such that an email vote after the meeting would be held. This protocol for voting was OK'd by Usha Rodriguez.

Brock Woodson provided some insight to the three relatively small changes in the document (see edited version).

One change, a request to remove faculty vote on the selected PTU head seemed to remove any means of faculty to deny a selection.

Similarly, there was concern that a faculty member selected to be PTU head should have recourse to decline.

In discussion, the only motion by Daniel Markewitz, seconded by Janette Hill was:

Motion to strike the word 'only' from the following sentence in section V. Procedures for Appointments:

This vote will be reported-only to the tenure-track faculty of the appointment unit, as well as to the department head, PTU head, or dean.

Vote was 15 in favor, 1 abstention (see vote on p. 2)

Thereafter, there was some discussion about the role of annual review in P&T or the PTU head in annual review.

Also, there is continuing discussion about different faculty (i.e., tenure track vs clinical) and how guidelines are creating divisions among faculty.

The committee agreed to email the four revisions in the document for a vote of the full FAC.

The meeting was adjourned.

 Motion to strike the word "only" from the following sentence from the Guidelines in Section V. Procedures for Appointment: "This vote will be reported only to the tenure-track faculty of the appointment unit, as well as to the department head, PTU head, or dean." This motion was made and voted on at the November 25, 2024 FAC meeting.
