The committee duties were outlined and the importance of well-written items and considering the appropriate channels for policy concerns, including taking items and asking questions to University System of Georgia (USG).

## **New Business**

- UGA's March 2025 NDAH updates were confirmed by USG to meet Board of Regents policy (Nov 2024), federal law, and USG's Jan 2025 directive; no further revisions required. Policy clarification may be sought from USG Faculty/Staff Councils. A resolution to request to reinstate the NDAH line referencing "(including sexual harassment and pregnancy), sexual orientation, gender identity, ethnicity" passed (10 Yes, 4 No, 2 Abstain) (See Appendix A for a detailed record of votes) and will proceed through to October Executive Committee meeting. Proposed 2025–26 priorities include salary compression, compensation, parking, traffic, healthcare, and daycare, with potential presentations by the Provost's Office, HR, and Bret Jackson.
